What is Antisocial Personality Disorder?

AKA- psychopathy or sociopathy in popular culture (not psychological terms)

Antisocial: breaks rules and laws for own gain; takes advantage of other people for personal gain; feels little or no remorse or guilt; appears friendly and charming on the surface; often intelligent

Usually begins in childhood or teens and continues in adult life.

Most often seen in culprits of serial murder otherwise known as serial killers.

SYMPTOMS

Antisocial personality disorder is diagnosed when a person's pattern of antisocial behavior has occurred since age 15 (although only adults 18 years or older can be diagnosed with this disorder) and consists of the majority of these symptoms:

Failure to conform to social norms with respect to lawful behaviors as indicated by repeatedly performing acts that are grounds for arrest

Deceitfulness, as indicated by repeated lying, use of aliases, or conning others for personal profit or pleasure

Impulsivity or failure to plan ahead

Irritability and aggressiveness, as indicated by repeated physical fights or assaults

Reckless disregard for safety of self or others

Consistent irresponsibility, as indicated by repeated failure to sustain consistent work behavior or honor financial obligations

Lack of remorse, as indicated by being indifferent to or rationalizing having hurt, mistreated, or stolen from another

CAUSES

Researchers today don't know what causes antisocial personality disorder.

- Most professionals subscribe to a nature & nurture model of causation —
 - Causes of are likely due to biological and genetic factors
 - Social factors (such as how a person interacts in their early development with their family and friends and other children)
 - Psychological factors (the individual's personality and temperament, shaped by their environment and learned coping skills to deal with stress).
- This suggests that no single factor is responsible — rather, it is the complex and likely intertwined nature of all three factors that are important. If a person has this personality disorder, research suggests that there is a slightly increased risk for this disorder to be “passed down” to their children.

- Why are we as humans so interested in serial killers?
 - Ask yourself... why do I want to know about the motivations and details of a person whose morbid and horrific acts were committed against an innocent that was a brother, sister, husband, wife, mother or father?

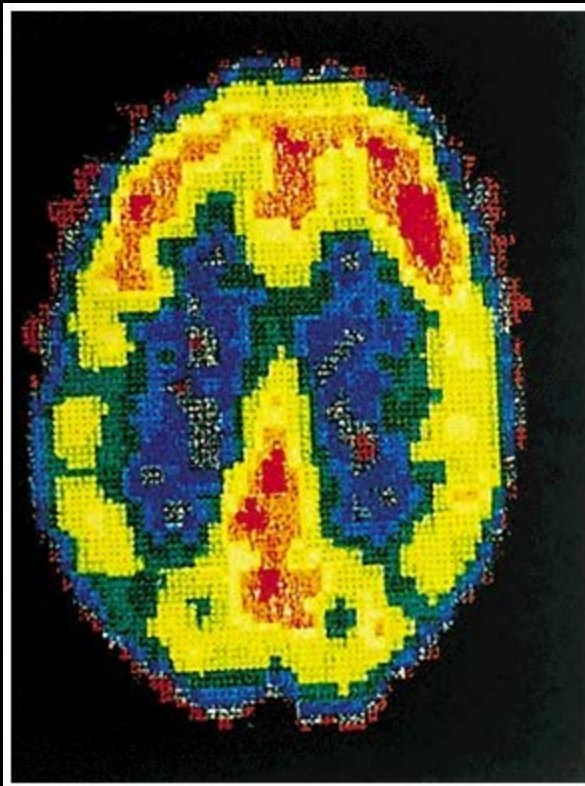

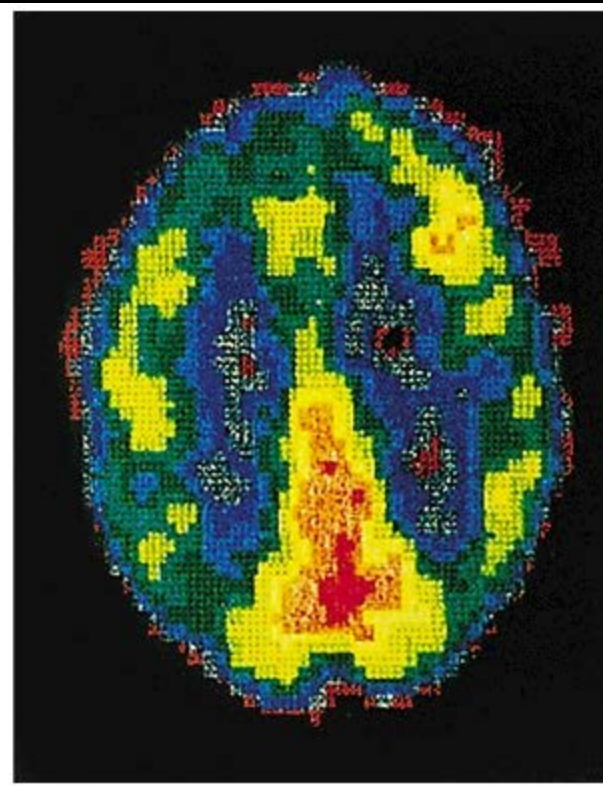
PET scans illustrate reduced activation in a murderer's frontal cortex

DSM CHARACTERISTICS OF SEVERAL PERSONALITY DISORDERS

Paranoid: suspicious, argumentative, paranoid, continually on the lookout for trickery and abuse, jealous, tendency to blame others, cold and humorless

Schizoid: has few friends; a "loner"; indifferent to praise and criticism of others; unable to form close relationships; no warm or tender feelings for other people

Schizotypal: also aloof and indifferent like the schizoid; magical thinking; superstitious beliefs; uses unusual words and has peculiar ideas; a very mild form of schizophrenia

Borderline: very unstable relationships; erratic emotions; self-damaging behavior; impulsive; unpredictable aggressive and sexual behavior; monophobia; easily angered

Histrionic: overly dramatic; attention seekers; easily angered; seductive; dependent on others; vain, shallow, and manipulative; displays intense, but often false emotions

Narcissistic: grandiose; crave admiration of others; extremely self-centered; feel they are privileged and special; expects favors from others; emotions are not erratic

Obsessive-Compulsive: perfectionists; preoccupied with details, rules, schedules; more concerned about work than pleasure; serious and formal; cannot express tender feelings

Passive-Aggressive: indirectly expresses anger by being forgetful and stubborn; procrastinates; cannot admit to feeling angry; habitually late

Avoidant: Be easily hurt when people criticize or disapprove of them; hold back too much in intimate relationships; be reluctant to become involved with people, avoid activities or jobs that involve contact with others; be shy in social situations out of fear of doing something wrong; make potential difficulties seem worse than they are; hold the view they are not good socially, not as good as other people, or unappealing

Analysis of Serial Killers**

SERIAL KILLER DEFINITION

Serial murder is defined by three key elements:

1. **Number**
2. **Time**
3. **Motivation**

- Most murderers have only one victim
- Serial killers, by definition, have multiple victims.
 - Minimum number of victims: **2 to 10**, with a modal value of 3.
- **Time** is designed to distinguish serial killers from mass murderers and spree killers.
- **Mass murderers:** multiple victims in a single episode
- **Spree killers:** have multiple victims in several separate but related episodes, in neither case is there an emotional cooling off period between murders.
- **Serial murder:** there is a cooling off period of several days, weeks, months, or years.
- To differentiate serial killers from professional hit men, political terrorists, and military combatants, most definitions of serial murder omit individuals who kill exclusively for financial, political, or military gain.

SERIAL KILLERS DEMOGRAPHICS

- Men are responsible for the vast majority of crimes committed worldwide.
- An even greater percentage of men engage in serial murder.
- Ratio of male to female criminals: 9:1
- Ratio of males to females who commit serial murder: 19:1
- Although rare, female serial killers do exist and are more likely to work in pairs than male serial killers.

SERIAL KILLERS DEMOGRAPHICS

- Young adults are the most common targets of serial murder, but victims could be anywhere from their early childhood to late adulthood.
- Some serial killers prefer male victims
- Others prefer female victims, and others have no gender preference.
- Whereas the victims of single-incident murder are often family members, friends, and acquaintances, the victims of serial murder are nearly always strangers.

RESEARCH ON SERIAL MURDER

- Most serial killers work alone, although in 10% to 37% of cases serial killers work in pairs.
 - When a pair, one member assumes dominant role, other member assumes the submissive role.
- Serial killers generally select their victims, and the victims they find most appealing are those that seem preoccupied, distracted, or vulnerable and those whose disappearance would be least likely to be noticed.
 - Most often: single women, transients, runaway teenagers
- Method of murder: prefer to strangle, stab, or beat their victims rather than shoot them (the staple of single-incident murder).

Why?

- It has been speculated that “hands-on” murder techniques such as strangulation, stabbing, and beating offer the serial killer greater personal control over the victim than killing from a distance. Once the crime has been committed, the serial killer is more likely than the single-incident killer to try and deceive law enforcement by burying the body, moving the body to another location, or altering the crime scene.

SERIAL KILLER CHARACTERISTICS

No single psychological or personality profile that all serial killers fit

Certain characteristics that have been observed on a fairly regular basis in serial killers:

1. More likely to have a history of criminal involvement, often in the form of petty criminality, than a history of psychiatric treatment.
2. Psychopathic personality. This may explain why some serial killers are adept at disarming their victims without coercion and avoiding apprehension for an average of 4 to 5 years.
3. Objects the serial killer collects from the crime scene or takes from the victim, commonly called trophies, not only help the killer relive the murder but can also trigger future killings. Several studies indicate that it is not unusual for an individual to entertain murder fantasies for several years before acting on them.

MOTIVATION OF SERIAL KILLERS

Sexual motives- 50% of the serial killers interviewed, a clear sexual motive has been identified.

In comparison with the emotional and social issues that frequently motivate single-incident homicide, serial homicide is more often motivated by sexual fantasies and desires.

Serial Killer

- Kill one person, takes large amount of time between killings
- If they feel any sense of exclusion, it is probably chosen.
- It's the type of exclusion that says 'I am better than everyone else,' or 'I am different from everyone else.'

Mass Murderer

- Kill a large amount of people at one time
- Often kill themselves after killing many others
- Feel victimized and excluded from society and believe they have run out of options.
- Engaging in mass murder is "an attempt to give their death what their life noticeably lacked: meaning.

OTHER MOTIVATIONS

- Revenge- possibly a more powerful motive for serial murder than either psychosis or any sexual reasons.
- Preliminary evidence that some serial killers target victims who display characteristics symbolic of a group or person they despise.
- Ted Bundy- targeted young women with long dark hair parted down the middle because these were prominent features of a woman who had spurned him years earlier.
- John Wayne Gacy- preyed on young males as a way, perhaps, of venting hatred toward his own homosexuality.
